# Tips for the Grant Search

## TIMING IS EVERYTHING

Most grant deadlines are scheduled between January and May, although some opportunities are rolling (e.g. no deadline), and some are available on a monthly basis. However, in many cases, the grant application will not become available until 14 days before the deadline. In other instances, you may be required to submit a brief Letter of Interest (LOI); if approved, you will be invited to submit a full application that is due 1-2 months after approval. Deadlines also change without warning. You should plan to frequently monitor the websites of any grants for which you might apply.

## BEWARE OF SCAMS

Always read the Official Rules and confirm that the rules state that no entry fee is required and that a purchase does not improve an applicant's likelihood of receiving funds. Please note that this caveat does not apply to the grant opportunities that are available only to members of credible organizations like the National Association for the Self Employed, which may require paid memberships. Additionally, be sure you know who you're sending personal business or financial information to. For example, any official email from the SBA (Small Business Administration) will end in @sba.gov. Be leery of outside organizations posing as the SBA, or other funders.

## UNDERSTAND WHO IS THE ELIGIBLE APPLICANT

With many state and federal grants, the official applicant must be the Town or City in which your business is located, even if the project benefits you as a business. Before applying, contact your municipal office to discuss the grant opportunity and the process your municipality has for grant applications. You may need to ask your Town or City Council for approval and advertise a Public Hearing for local input.





# Tips for Applying

## PREPARE YOUR APPLICATION AHEAD OF TIME

Grant applications require extensive documentation - both financial and organizational - plus a compelling narrative explaining your funding request. Since preparation takes significant time while running a business, start before the application period opens. Review last year's application to understand requirements, as they typically remain similar year-to-year, giving you time to adapt to any changes when the new version launches.

## GET AN EXTRA SET OF EYES TO READ YOUR APPLICATION

Funders do not know your business as well as you do, so it can be helpful to get an outside perspective. Is your application easy to understand? Does it convey the importance of funding for your business growth and local economic development? Ask an advisor, savvy friend, or fellow business owner to help; you don't need to pay someone to do this review for you.

## INCORPORATE A BROADER CONTEXT

Support your narrative with focused data from statistics, Census figures, industry studies and news reports - prioritizing local/state facts over global ones. Demonstrate the scope of the problem in Maine, who you serve, and how others have successfully implemented your proposed solution. For instance, cite studies on storefront aesthetics' impact on consumers when requesting façade funds, or compare your wages to county medians using Census data.

## KNOW YOUR FUNDER

Understand what is important to your funder and tailor your application to it. You can find a funder's mission and values on the funder's website. While you're researching, look at the types of projects the funder has previously funded and ensure that your proposed project aligns well with them.

Sign up for their e-newsletter and follow them on social media to understand what current issues they're talking about.



# VOCABULARY



**Entitlement Community:** Specific municipalities which receive their own Community Development Block Grant (CDBG) fund allocation. If your business is located in one of these communities, you would apply to the municipality, not the State of Maine's Dept. Economic & Community Development. Entitlement Communities include: Auburn, Bangor, Biddeford, Lewiston, Portland, and all other municipalities of Cumberland County except for Brunswick, Casco, and Frye Island.

**Match:** Many grant programs require matching funds, or match. This is additional funding to supplement the grant funds and complete the project. Depending on the organization, eligible sources of match may or may not include: your own investment; other grants; loans; in-kind donations, time, services (e.g. a graphic designer agrees to work for free for you); or your own labor and investment. In addition, a funder may require that the match not be expended before you receive their grant funds. It's important to understand how each grantor defines match – review the grant application carefully for details.

**TIF:** Tax Increment Financing (TIF) is a tool to encourage investment in under-developed, blighted areas. Administered by each municipality, a TIF district allows developers of properties within the district to recover a portion of the property tax increase that their development generates. For example, if a developer redevelops a blighted building, the property tax valuation increases from \$5 to \$10. Under a Credit Enhancement Agreement (CEA) signed with the municipality, the developer may recover a portion of the \$5 increase in order to offset some of the expenses of development. The remaining property tax gain will go to a TIF fund designed to support designated economic development projects.



# GRANTS FOR SMALL BUSINESSES

The following list of grants for small businesses is organized by how the grant funds may be used. Please note that the deadline may change year to year; we encourage you to research these grant opportunities using the given websites for updated information.

## Research, Development, and Innovation

### NewSchools Venture Fund

**Description:** Grant investment for innovative solutions that expand the definition of what works in the U.S. education system. Each funding cycle has specific funding priorities, including “learning solutions” and “teaching reimaged”.

**Funding Amount:** \$150,000 - \$250,000

**Match:** No

**Deadline:** January 8, 2025

**Eligibility:** Applicant must be early-stage (no more than 3 years old) or an established organization with a new initiative).

**How to Apply:** Visit [newschools.org/apply-for-funding](https://newschools.org/apply-for-funding).

### Maine Aquaculture Innovation Center

**Description:** Grants to encourage industry development by promoting applied aquaculture research.

**Funding Amount:** \$5,000 - \$50,000

**Match:** 1:1 match (100% of requested grant amount)

**Deadline:** By invite only

**Eligibility:** Project must relate to aquaculture research.

**How to Apply:** Visit [MAIC's Grants webpage](#) and contact MAIC at [www.maineaquaculture.org/contact](http://www.maineaquaculture.org/contact) to determine if your research project is a good fit. You may also review MAIC's [research priority report](#) on their website.





## Research, Development, and Innovation *(continued)*

### Maine Technology Institute

**Description:** Grants for businesses and individuals to support Maine's innovation economy.

**Funding Amount:** Meet with an MTI Advisor to discuss an appropriate funding request.

**Match:** 1:1 match (100% of requested investment amount)

**Deadline:** Rolling

**Eligibility:** Your business must fit within these seven targeted sectors: biotechnology; composites & advanced materials; environmental technology; forest products & agriculture; information technology; marine technology & aquaculture; and precision manufacturing.

**How to Apply:** Complete an Online Intake Form at [mainetechnology.org](https://mainetechnology.org) and meet with an MTI advisor.

### Maine Technology Institute – MTAF 3.0 Fund

**Description:** Interest-free loans, with forgiveness potential, for businesses to invest in infrastructure to support the continuum of research, development, and commercialization within MTI's seven targeted technology sectors. Funds may be used for capital construction and/or facility renovations, purchase of equipment, and technology systems.

**Funding Amount:** Up to \$2.5 million

**Match:** At least 50%; up to 50% of the loan may be forgiven

**Deadline:** November 13, 2025

**Eligibility:** Business must have established a Maine-based location and align with one of the seven targeted sectors: life sciences & biomedical technologies; environmental and renewable energy technologies; information technologies; advanced technologies for forestry and agriculture; aquaculture and marine technologies; composites and advanced materials; precision manufacturing.

**How to Apply:** Review application materials and apply at [mainetechnology.org](https://mainetechnology.org).





## Research, Development, and Innovation *(continued)*

### Small Business Innovation Research (SBIR)

**Description:** Grants to support scientific excellence and the commercialization of technological innovation through the investment of federal research funds to support a strong U.S. economy.

**Funding Amount:** Determined each year; generally Phase I is \$250,000 and Phase II is \$650,000.

**Match:** Yes

**Deadline:** Determined by each government agency that participates in SBIR

**Eligibility:** Small business with high-tech innovations in the R&D phase. Funds can not be used for commercialization activities.

**How to Apply:** Contact [Central Maine Growth Council](#), Maine's official SBIR/STTR support organization.

### Tiny Fellowship from 4.0

**Description:** Technical assistance, accompanied by a grant, to support founders of education-focused ideas in developing a proof of concept by conducting a pilot.

**Funding Amount:** \$5,000


**Match:** No

**Deadline:** October 2025

**Eligibility:** Founder of an education-focused idea

**How to Apply:** Visit [4pt0.org/tiny](https://4pt0.org/tiny).





## Artistic Project Creation/Continuation

### Ellis-Beauregard Foundation – Project Grant

**Description:** Funding to support bold, risk-taking artwork within or outside standard exhibition venues. Compelling projects utilize unconventional approaches, collaboration, critical dialogue, and innovative community engagement methods.

**Funding Amount:** \$10,000

**Match:** No

**Deadline:** August 1, 2025

**Eligibility:** Artist is at least 18 years old, based in Maine, and not a student. Artist teams are eligible.

**How to Apply:** Visit [ellis-beauregardfoundation.org](https://ellis-beauregardfoundation.org) and complete the application.

### Gottlieb Foundation – Individual Support Grant

**Description:** Grants to support mature artists who have dedicated their lives to developing their art in the media of sculpture, painting, and printmaking.


**Funding Amount:** \$25,000

**Match:** No

**Deadline:** January 15, 2025

**Eligibility:** An artist in the above media who has been creating art for at least 20 years and is in financial need.

**How to Apply:** Visit [gottliebfoundation.org](https://gottliebfoundation.org) and complete the online application.



## Artistic Project Creation/Continuation (*continued*)

### Maine Arts Commission – Artist Project Grant

**Description:** Grants to assist individual artists with the creation of new artistic work, the continuation of existing practices, professional development, or bringing their art to the public.

**Funding Amount:** \$2,500

**Match:** No

**Deadline:** February 26, 2025

**Eligibility:** A full-time, non-student Maine artist over the age of 18.

**How to Apply:** Visit [mainearts.maine.gov](https://mainearts.maine.gov), create a Maine Arts Commission account, and complete the online application.

### Maine Arts Commission – Artist Springboard Grant

**Description:** Grants to assist individual artists who have *not* been previously funded by the Maine Arts Commission. Funds may be used toward the creation of new artistic work, the continuation of existing practices, professional development, or bringing their art to the public.


**Funding Amount:** \$1,500

**Match:** No

**Deadline:** February 26, 2025

**Eligibility:** A full-time, non-student Maine artist over the age of 18 who has not been previously awarded Maine Arts Commission funding (excepting apprenticeships).

**How to Apply:** Visit [mainearts.maine.gov](https://mainearts.maine.gov), create a Maine Arts Commission account, and complete the online application.



## Artistic Project Creation/Continuation *(continued)*

### Maine Bureau of Parks & Lands – Allagash Wilderness Waterway Artist Residency

**Description:** A two-week Residency to immerse a visual artist in the exceptional AWW wilderness to interpret and share their experience through their art.

**Funding Amount:** \$1,000

**Match:** No

**Deadline:** February 3, 2025

**Eligibility:** Applicant must be a visual artist and agree to holding at least one public program within a year of their stay that showcases their experience and the art inspired by their stay. Must also gift one original piece of their Allagash-inspired art to the Bureau.

**How to Apply:** Visit [maine.gov/dacf/parks](https://maine.gov/dacf/parks).

### Maine Community Foundation - Leonard & Renee Minsky Fund for Arts Education

**Description:** Grants to support professional visual and/or performing arts artists to work with teachers to bring arts into the classroom.

**Funding Amount:** \$1,000 (at least 75% of funds will support the artist's fee)


**Match:** No

**Deadline:** December 16, 2025

**Eligibility:** Applicant must be a school in Washington or Penobscot County, applying for grades 3-5.

**How to Apply:** Visit [mainecf.org](https://mainecf.org) and complete the online application.





## Artistic Project Creation/Continuation *(continued)*

### Mayo Street Arts – Traditional Arts Network (TAN) Fund

**Description:** Grants to support traditional artists and arts organizations in Maine who are preserving a cultural heritage from a country of origin outside of the continental United States and/or their indigenous community.

**Funding Amount:** \$500 - \$1,000

**Match:** No

**Deadline:** May 31, 2025

**Eligibility:** May not have received TAN funding for the past two consecutive years.

**How to Apply:** Visit [mayostreetarts.org/TAN/](http://mayostreetarts.org/TAN/).

### OPERA America – Opera Grants for Women Composers (Discovery)

**Description:** Grants to support female-identifying composers in developing new operas.

**Funding Amount:** \$15,000

**Match:** No

**Deadline:** Letter of Intent due September 2025

**Eligibility:** Must be a female-identifying composer with U.S. citizenship, permanent residency, or DACA status.

**How to Apply:** Visit [operaamerica.org/programs/services/grants-awards](http://operaamerica.org/programs/services/grants-awards) and apply.

### Space 538 – Kindling Fund

**Description:** Grants to support artist-organized projects that engage audiences and incorporate the visual arts in inventive and meaningful ways.

**Funding Amount:** \$3,000 - \$7,000

**Match:** No

**Deadline:** November 16, 2025

**Eligibility:** Must be an artist, art writer, curator, or art organizer in the state of Maine. May not be a student.

**How to Apply:** Visit [space538.org/kindling-fund](http://space538.org/kindling-fund)





## Artistic Project Creation/Continuation *(continued)*

### Space 538 – Sonic Visions Fund

**Description:** Grants to support multi-dimensional projects led by Maine musicians. Funding and additional support may be used for production, marketing, and documentation.

**Funding Amount:** \$3,000 plus an additional \$500-\$1,000 stipend for touring within Maine

**Match:** No

**Deadline:** July 27, 2025

**Eligibility:** Lead applicant must be a Maine-based musician, and the project must have a public component.

**How to Apply:** Visit [space538.org/event/sonic-visions-fund-info-session-2025](https://space538.org/event/sonic-visions-fund-info-session-2025)

### VIA Art Fund – Artist Production Grant

**Description:** Grants to support the production and exhibition of new artistic commissions, most often exhibited in public spaces with high levels of public engagement.

**Funding Amount:** \$25,000 - \$100,000

**Match:** Grants typically fund 35-40% of the total project budget

**Deadline:** There are two semiannual rounds, and each requires a letter of intent and a full application upon invitation. Next round: Letter of Intent is due May 15, 2025.

**Eligibility:** Applicant may be a U.S. based or international artist, curator, nonprofit, cultural institution, art production platform, biennial and/or festival.

**How to Apply:** Visit [viaartfund.org/apply/](https://viaartfund.org/apply/) and complete the online application.



## Marketing and Storefront Improvement

### Maine Community Development Block Grant – Community Enterprise Grant

**Description:** Grant funds for business façade improvements and streetscapes in downtown and village areas that are experiencing blight.

**Funding Amount:** \$25,000

**Match:** 25% of requested grant amount

**Deadline:** February 21, 2025

**Eligibility:** Applicant must be a unit of local government, though you may apply directly to your municipality if it is an “entitlement community” (see [slide 6](#) for a list).

**How to Apply:** Visit [maine.gov/decd/community-development/cdbg-program](https://maine.gov/decd/community-development/cdbg-program), review the [Application Process](#) and [Program Statement](#), then contact your municipality.

### Maine International Trade Center - State Trade Expansion Program (STEP)

**Description:** Funding to support Maine companies who seek new international sales and export growth. This is a reimbursement-based grant. Grants may support a variety of projects for International Business Development or Export Skills Development.

**Funding Amount:** \$5,000 - \$10,000

**Match:** 25% of total project costs.

**Deadline:** Accepting applications up until March 31, 2026

**Eligibility:** Applicant must be a small business with at least one year in operation and at least 51% of its operations located in Maine.

**How to Apply:** Visit [MITC's webpage](#) for details.





## Marketing and Storefront Improvement *(continued)*

### **National Association of REALTORS – Placemaking Grants**

**Description:** Grants to fund state and local REALTOR® association-led projects that create new, outdoor public gathering spaces and destinations in a community on unused or underused sites.

**Funding Amount:** Up to \$7,500

**Match:** Not stated

**Deadline:** Re-opening January 2026

**Eligibility:** Applicant must be a local or state REALTOR association.

**How to Apply:** Find more information and apply by visiting [realtorparty.realtor/community-outreach/placemaking](https://realtorparty.realtor/community-outreach/placemaking).

### **New Ventures Maine - Mini Marketing Grant**

**Description:** Grants to strengthen access to markets for small businesses by supporting the development of professional, well-planned marketing tools, materials, and activities.

**Funding Amount:** \$1,000

**Match:** 25% of the funding request amount

**Deadline:** February 28, 2025

**Eligibility:** Small business with 5 or fewer employees, sales within the last 12 months, and gross annual sales of no more than \$150,000 in the previous calendar year.

**How to Apply:** Find more information and contact your local NVM office by visiting [newventuresmaine.org](https://newventuresmaine.org).





## Marketing and Storefront Improvement *(continued)*

### Municipal Marketing & Façade Improvement Grant Programs

Many towns and cities in Maine offer grant funding to businesses and property owners for the restoration of downtown storefronts. If this list does not include the town or city in which your business is located, we recommend that you visit your town/city's website to see if they are starting a grant program. As well, many façade grant programs are temporary and may not be available in the future.

#### **Augusta – Sign Grant**

**Description:** Grants toward the cost of new signage for new or existing businesses in downtown Augusta.

**Funding Amount:** \$500

**Match:** Not stated

**Deadline:** Rolling

**Eligibility:** Located in downtown Augusta; sign design must conform with city codes.

**How to Apply:** Visit [augustadowntown.com/opportunity](http://augustadowntown.com/opportunity) and e-mail [director@augustadowntown.com](mailto:director@augustadowntown.com) to request an application.

#### **Ellsworth – Downtown Façade Improvement Program**

**Description:** Grants to protect and preserve the authenticity of downtown Ellsworth. Available to owners of commercial properties to improve or restore the original character of their buildings.

**Funding Amount:** Up to \$25,000

**Match:** 25% of total project cost

**Deadline:** March 14, 2025

**Eligibility:** Applicant must be the owner of a commercial property located in downtown Ellsworth that is at least 50 years old. See online guidelines for more details.

**How to Apply:** Visit [ellsworthmaine.gov/façade](http://ellsworthmaine.gov/façade).





## Marketing and Storefront Improvement *(continued)*

### Municipal Marketing & Façade Improvement Grant Programs

#### **Fairfield – Façade Improvement & Marketing Assistance Program**

**Description:** Grants to enhance the viability of local commercial businesses in Fairfield through façade improvements or advertising & branding efforts.

**Funding Amount:** Up to \$25,000 for façade improvements | up to \$3,000 for marketing project

**Match:** 50% of total project cost

**Deadline:** Rolling

**Eligibility:** Located within the Town of Fairfield. Total marketing project cost must exceed \$1,000; total construction cost must exceed \$3,000.

**How to Apply:** Visit the Town of Fairfield’s [Business Resources webpage](#) for the application.

#### **Houlton – Façade Grant Program**

**Description:** Grants encourage private investment improving downtown Houlton’s historic facades.

**Funding Amount:** Up to \$5,000

**Match:** 50% of total project cost

**Deadline:** Rolling

**Eligibility:** Located within the Houlton Downtown TIF District

**How to Apply:** Visit [houlton-maine.com/departments/economic-development](http://houlton-maine.com/departments/economic-development) for application and contact information.





## Marketing and Storefront Improvement *(continued)*

### Municipal Marketing & Façade Improvement Grant Programs

#### **Lewiston – Façade Improvement for Commercial Buildings Program**

**Description:** 100% deferred loan to enhance the appearance of the commercial area, encourage private investment in storefronts, and assist business owners with rehabilitating storefronts. Eligible activities can include exterior renovations, including the entryway, exterior lighting, signage, window repair/replacement, masonry, repointing, painting, and awnings. Payable upon ownership change.

**Funding Amount:** Up to \$35,000 for owners | \$2,000 for tenants

**Match:** 1:1

**Deadline:** Rolling as long as funding is available

**Eligibility:** Property owner or tenant business improvements must either: create jobs for LMI individuals; provide 51% of services to LMI individuals; or improve a blighted commercial storefront. Must be commercial business or property in Lewiston.

**How to Apply:** Visit [lewistonmaine.gov](http://lewistonmaine.gov); guidelines [here](#)

#### **Lewiston – Façade Improvement for Historic Preservation Program**

**Description:** Similar to above, but for mixed-used properties on National Register of Historic Places.

**Funding Amount:** Up to \$35,000

**Match:** 1:1 (100% of requested funding amount)

**Deadline:** See “How to Apply”

**Eligibility:** Similar to above; must be mixed-use property on National Register.

**How to Apply:** Visit [lewistonmaine.gov](http://lewistonmaine.gov); guidelines [here](#)





## Marketing and Storefront Improvement *(continued)*

### Municipal Marketing & Façade Improvement Grant Programs

#### **Richmond Downtown and Village District – Façade Grant Program**

**Description:** Supports façade improvement projects to preserve downtown’s unique character and eliminate/prevent conditions of blight. Projects must be complete within 6 months of approval.

**Funding Amount:** 50% of total project cost, up to \$20,000

**Match:** 1:1 (100% of requested funding amount)

**Deadline:** March 31, 2025

**Eligibility:** Applicant may be property owner or tenant of mixed-use, commercial, or residential property in the downtown TIF zone or Pipeline/Compressor Station TIF zone.

**How to Apply:** Visit [richmondmaine.com/departments/economicdevelopment](https://richmondmaine.com/departments/economicdevelopment) to view the application materials.

#### **Saco – Façade Grant Program**

**Description:** Grants to support economic development and community revitalization by funding façade improvement activities in Downtown and Cape Ellis areas.

**Funding Amount:** 50% of total project costs, up to \$15,000

**Match:** 1:1 (100% of requested funding amount)

**Deadline:** Rolling until funding is exhausted

**Eligibility:** Business must be located in Saco (review specific zones online) and have fewer than 50 employees. Applicant may be property owner or tenant.

**How to Apply:** Visit [sacomaine.org](https://sacomaine.org) and contact [Torie Gorman](#)





## Marketing and Storefront Improvement *(continued)*

### Municipal Marketing & Façade Improvement Grant Programs

#### **South Berwick – Downtown Façade Grant Program**

**Description:** Grants to support economic development and community revitalization through a variety of façade improvement projects.

**Funding Amount:** 50% of total project costs, up to \$10,000

**Match:** 1:1 (100% of requested grant amount)

**Deadline:** Rolling until funding is exhausted

**Eligibility:** Applicant may be property owner or tenant of a commercial property in the designated downtown opportunity area.

**How to Apply:** Visit [southberwickmaine.org](https://southberwickmaine.org), review the [application packet](#), and contact [DeCarlo Brown](#).

#### **Westbrook – Downtown Façade Improvement Grant Program**

**Description:** Grants to assist businesses and property owners in making physical improvements to their building exterior.

**Funding Amount:** Up to \$15,000

**Match:** 50% of total project cost

**Deadline:** Rolling until funding is exhausted

**Eligibility:** Located within Westbrook's downtown district.

## Capital Acquisition and Infrastructure Upgrade

### Efficiency Maine – Manufacturer Thermal Efficiency Projects

**Description:** Incentives to reduce a manufacturers’ fuel usage, including natural gas, oil, biomass, and other fuels.

**Funding Amount:** See “How to Apply”, as funding differs per project

**Match:** Yes (depends on project)

**Deadline:** June 30, 2025

### Island Institute – Spark! Grant

**Description:** Grants to support working waterfront energy projects that improve energy efficiency, switch to renewable energy, and/or reduce consumption of fossil fuels. Current priorities include shoreside charging infrastructure, charging infrastructure, shoreside renewable energy generation, marine electrification, energy efficiency, and weatherization.

**Funding Amount:** \$4,000


**Match:** 1:1 (100% of requested grant amount)

**Deadline:** June 1, 2025

**Eligibility:** Applicant must be a working waterfront business based in Maine’s island and/or coastal communities, including: processing facilities, co-op buildings and offices, shared equipment/ storage sheds/workshops, fishing vessels, and docks and yards.

## Capital Acquisition and Infrastructure Upgrade

### Maine Community Development Block Grant (CDBG) – Economic Development Program

**Description:** Grants to provide gap funding for the purchase of equipment or working capital to create jobs for low-to-moderate income individuals.

**Funding Amount:** Up to \$30,000 per job created, up to \$100,000

**Match:** Yes, but amount is unstated. Funder emphasizes that funding is to fill a gap in financing.

**Deadline:** 1<sup>st</sup> of the month, starting in July 2025

**Eligibility:** At least 51% of the jobs created by the project must be held by low-to-middle income workers. Applicant must be the municipality. All jobs must be permanent and measured as FTE.

**How to Apply:** Visit [maine.gov/decd/community-development/cdbg](https://maine.gov/decd/community-development/cdbg), review the Program Statement, then select the most recent [Economic Development Program application](#), and contact your local municipality to discuss a potential application.

**Note:** In most cases, the municipality (not the business owner) is the applicant for this grant. The exception is “[entitlement communities](#)” – apply directly to your municipality.

### Maine Dept. Economic & Community Development – Coworking Development Fund

**Description:** Grants to support the success of coworking spaces which offer opportunities for entrepreneurship, stimulate innovation in the State by increasing the availability of collaborative workspace environments and address a regional market demand for affordable work environments.

**Funding Amount:** \$25,000

**Match:** 1:1 (50%)

**Deadline:** March

**Eligibility:** Coworking business may be currently operating or launching.

**How to Apply:** Visit [maine.gov/decd](https://maine.gov/decd)

### Maine Guide to Climate Incentives

**Description:** A guide to incentives available for businesses that seek to invest in electric vehicles, electric vehicle chargers, rooftop solar, and energy efficiency projects.

### Maine Regional Planning Organizations – Brownfields Grants

**Description:** Grants to assess and remediate potential environmental contamination concerns to enable the reuse, redevelopment, or expansion of that site.

**Funding Amount:** Varies according to region and phase of project

**Match:** Varies

**Deadline:** Varies

**Eligibility:** Site must be considered “blight” and unable to be redeveloped because of perceived or actual environmental contamination concerns. Applicant may need to be the municipality.

### Moosehead Lake Economic Development Corp. – Allen Family Economic Growth Fund

**Description:** Grants to help new business owners start their business. Funds may support business start-up operations including planning, market research, and legal filings.

**Funding Amount:** \$2,500

**Match:** 50%

**Deadline:** Rolling

**Eligibility:** Applicant must be starting a business in the Moosehead Lake region.

## Capital Acquisition and Infrastructure Upgrade (*cont.*)

### Town of Gorham – CapEx Matching Grant Program

These single, one-time procurements will help grantees accelerate plans for growth, and create opportunities for expansion, innovation and job creation in Gorham. Targeted sectors include agriculture, manufacturing, and retail.

**Funding Amount:** \$2,500 - \$12,000

**Match:** 50%

**Deadline:** July 31, 2025

**Eligibility:** Applicant business must be based in Gorham; visit online application for more guidelines.

### USDA – Rural Business Development Grant

**Description:** Grants to support targeted technical assistance, training, and other activities leading to the development or expansion of small and emerging private businesses in rural areas. **Funding Amount:** N/A (smaller grants given priority)

**Match:** Yes; a higher percentage of match will receive higher points in application scoring.

**Eligibility:** Applicant must be a municipality or nonprofit corporation. Must be located in a rural area; that is, outside the urbanized periphery of a city with more than 50,000 residents.

Business must have fewer than 50 employees.

### USDA – Rural Energy for America Program

### US Dept. Energy – Industrial Training & Assessment Centers (ITAC) Implementation Grant

**Funding Amount:** Up to \$300,000

**Match:** 1:1 (50% of total project costs)

**Deadline:** Rolling, reviewed quarterly

**Eligibility:** Applicant must be a small or midsize manufacturer with fewer than 500 employees and under \$100M in annual revenue. To get an assessment, must spend at least \$100,000 on annual energy costs.

### City of Portland – Growing Child Care Grant

**Eligibility:** A for-profit business in the following sectors: agriculture, forestry, & fishing; manufacturing; long-distance freight transportation; software publishing; data processing and computer design services; engineering, architecture, and scientific R&D services

**Match:** Not stated

**Deadline:** 1<sup>st</sup> of the month, starting July 2025

**Eligibility:** Applicant must be a business with 5 or fewer employees, including the owner. Owner's household income must meet the Low-to-Moderate federal standard. Must not be located in an [entitlement community](#).
